

A selection of HSRC key performance highlights and achievements: 1 April to 30 June 2012

Organisational developments

The HSRC achieved an independently verified Level 3 BB-BEE (Broad-Based Black Economic Empowerment) rating. This means that South African institutions procuring services from the HSRC, and wishing to measure their levels of compliance with the Codes of Good Practice Procurement Scorecard, can recognize 110% of their investment in HSRC work as BEE expenditure.

Progress made against targets set in the 2012/13 Annual Performance Plan

HSRC's first quarter performance against strategic indicators is covered in a separate report supplemented by a cover letter explaining the performance in detail.

Meeting with Ministers, government departments and Parliament

The annual performance plan of the HSRC was presented to the Portfolio Committee on Science and Technology on 25 April 2012. The plan was well received and discussions were constructive.

The Minister of Science and Technology and the Chairperson of the HSRC Board signed the Shareholder's Compact for 2012/13 in Pretoria on the 7 May 2012. As per the reporting obligations prescribed in the Shareholder's Compact, the HSRC submitted its annual financial statements and information on predetermined objectives by the deadline of 31 May 2012 to the Auditor-General of South Africa, National Treasury and the Department of Science and Technology.

The Chief Executive Officer (CEO) and the Executive Director (ED): Education and Skills Development met with Minister of Higher Education and Training to discuss the Labour Market Intelligence Project on 3 April 2012. It was a very useful engagement of ensuring that research is informed by policy needs. A follow-up workshop was held on 3 and 4 May to thrash out the research themes and questions.

The CEO met with the Head of Health in the Western Cape, Professor Househam, on 5 June, to discuss matters related to the National Health Insurance.

Meetings with key stakeholders in the Limpopo province included a meeting with the Research Forum, facilitated by the Office of the Premier and attended by provincial higher education institutions and government departments, on 18 April. The province will be collaborating with the HSRC around the establishment of its research repository, to host all recent research findings pertaining to the province. Towards the end of May, the CEO and Professor Margaret Chitiga-Mabugu met with Mr. Solly Kgopong, Senior general Manager, Economic Development Department of Economic Development, Environment and Tourism Limpopo, also around opportunities for research collaboration.



Representatives of the HSRC Research Ethics Committee (REC) attended a meeting hosted by the National Health Research Ethics Council (NHREC) on 3 May 2012. The meeting was attended by representatives from all RECs registered with the NHREC. Matters discussed at the meeting included preliminary findings of the first audit conducted on behalf of the NHREC, where the HSRC did well. The implications of Section 71 of the National Health Act, which recently came into effect, were also discussed. Although regulations are still awaited, there are concerns that this may have an unintended negative effect on the way in which research involving children is reviewed and approved from an ethical perspective.

The HSRC submitted a high-level MTEF infrastructure budget bid on 14 June 2012. The proposal was for a Research Data Management Centre: A specialised facility to support longitudinal studies for Human and Social Dynamics in Development (HSDD). The Centre is intended to address national priorities, requirements for monitoring and evaluation, human capital development and possible foresight activities in the field of social innovation.

The CEO accompanied by DCEOs and EDs attended a bilateral meeting with DST on 21 June 2012. The agenda included strategic and structural matters including the incorporation of the Africa Institute of South Africa (AISA) into the HSRC, and the role and placement of CeSTII regarding data collection for the annual Research and Experimental Development (R&D) Survey. The need for a trilateral meeting between the HSRC, DST and NRF were also discussed. Support for funding of Longitudinal Studies in the HSRC, a Research Internship proposal, and World Social Science Forum in 2015 were also discussed, as were a concept note on the creation of an Institute of Science, Technology Innovation (ISTI) at the HSRC, and further refinement of plans and funding requirements for a Centre for African Studies at the HSRC. The meeting had positive outcomes. DST will be working with other government departments to support the HSRC to undertake longitudinal studies. With respect to AISA's integration, it was agreed that it will proceed as planned and funds were set aside for this process. The release of the report of the Ministerial Review Committee on the STI landscape was also noted. The HSRC submitted a response to recommendations of the committee on 29 June 2012.

At the request of the Statistician General, several staff members were nominated to represent the HSRC at <u>StatsSA's</u> National Coordinating Committee (NCC) as well as several Sectoral Working Groups for finalizing the MDG Country Report.

During the first quarter of 2012/13, the following work of the HSRC attracted particular attendance from the media:

- The *Military Veterans* seminar series, and lessons learned from contributions by various veterans at the seminars;
- Ongoing work in the context of the first national South African National Health and Nutrition Survey (SANHANES);
- Findings of the HSRC audit of Further Education and Training (FET) colleges as well as work dealing with mid-level skills (artisan) training;
- Discussions around employment creation, led by a distinguished HSRC researcher who also serves on the National Planning Commission (NPC), Dr Miriam Altman;
- Research on water service delivery, undertaken in the Eastern Cape under the stewardship of the Deputy Minister of Science and Technology and in collaboration with the CSIR;
- Discussions around Early Childhood Development, especially in the context of UNESCOsupported roundtable discussions. During this period, a team led by Professor Linda Richter (distinguished HSRC researcher) also refined a Diagnostic Review of Early Childhood Development on behalf of the Department of Performance Monitoring and Evaluation (DPME)

International networking and collaboration

The CEO participated as a moderator on the Healthcare and Pharmaceuticals program during the DTI and Deloitte's fourth Annual South African International Trade and Investment Conference from 11 to 12 April, where she served as a panellist on health care systems in Africa.



The DCEO: Research led an HSRC delegation to attend a CODESRIA – HSRC Collaboration Review Meeting in Dakar, Senegal on 3 and 4 May 2012. Other members of the delegation included the Director, Business Development & International Liaison, Ms Bridgette Prince, Dr Darlene Miller (ISSC Co-ordinator); Professor Refilwe (Nancy) Phaswana-Mafuya (Director, SAHARA Network) and Professor Francis Nyamnjoh (Chair, HSRC Press Editorial Board). The meeting focused on progress made with various joint projects, including collaboration in the field of publication, a research project on South Africa's role in Africa, and collaboration around the SAHARA programme. The two organizations will be key partners in planning for the 2015 World Social Science Forum.

The CEO in her capacity as President of the International Social Science Council chaired the meeting of the Executive Committee from 14 to 15 May in Montreal, Canada. The opportunity was also used to visit NHI sites in Toronto so as to inform the NHI plan under development in her capacity as chair on Ministerial Advisory Committee on NHI. She later also met with Professor Yaung, the ex-Minister of Health of Taiwan, to learn more about how this country implemented its version of a national Health Insurance.

The CEO, in her capacity as President of the ISSC attended the Forum on Science, Technology and Innovation for Sustainable Development in June 2012. The Forum brought together leading international scientists and policy-makers to explore the key role of interdisciplinary science and innovation in the transition to sustainable development, a green economy and poverty eradication. The aim was to help establish the research, technology and policy agendas that would be needed after Rio+20. The Forum was organized by ICSU, in partnership with UNSECO, the World Federation of Engineering Organizations (WFEO), the International Social Science Council, the Brazilian Ministry of Science, Technology and Innovation and the Brazilian Academy of Sciences. It was attended by more than 1000 delegates. A small HSRC delegation also participated in Rio+20, with Professor Ivan Turok contributing to the ISSC/ISCU Science Forum and Ms Diana Sanches in the ISSC Early Career Scientists and Narratives for Change event.

New Books Published by HSRC Press

The month of June saw the launch of the new *Voices of Liberation* publication series. The first book in the series, entitled *A revolutionary life: Ruth First* (by Don Pinnock) was launched at the Institute for Commonwealth Studies, London University on June 2012. The second book, focusing on the life of *Albert Luthuli* (by Gerard Pillay) was launched later the month, in Cape Town. More books in this series were commissioned during June 2012.

Researchers win top award for best research paper

The Commonwealth Scholarship and Fellowship Plan (CSFP) is an international programme under which <u>Commonwealth</u> governments offer post-graduate scholarships and fellowships to citizens of other Commonwealth countries around the world (South Africa included). Duncan Scott, a junior researcher in Human and Social Development (HSD), has been awarded the Commonwealth Scholarship for PhD studies (Sociology) and will be attending the University of Aberdeen in the United Kingdom from October 2012.

Individual Antiracism Award 2012
